## BILL.

## An Act to incorporate the General Hospital of the District of Three Rivers.

HEREAS certain members of the Clergy, Magistrates, and other Preamble. inhabitants of the District of Three Rivers, have prayed for the incorporation of an institution to be located in the City of Three Rivers, under the name of the "General Hospital of the District of 5 Three Rivers," and whereas urgent reasons have been assigned in support of the prayer thereof; Therefore Her Majesty, &c., enacts as follows :
