SUPERANNUATION FUND (Civil Service) :

1. Motion for a committee of the whole to consider a proposed Resolution, declaring that as the Fund is raised out of the compulsory contributions from the salaries of public officers, the whole of the Fund should be consecrated to their use and benefit, by applying it first to their personal relief according to law, and any surplus to the relief of their widows and orphans ; Debate thereon adjourned, 99. Order for further consideration discharged, 414.

2. House goes into committee to consider of amending the Superannuation Act ; Report a Resolution, reducing the abatement, &c. ; Bill presented, 155. See *infra*, 3.

3. Bill to amend the Civil Service Superannuation Act ; Ordered ; Presented, 155. Committed ; Considered ; Reported ; Passed, 230. By the Senate, 293. R.A., 433. (36 Vic., c. 32.)

Motion that Mr. Speaker do now leave the Chair ; Amendment moved, that in the opinion of this House, provision should be made, before Parliament rises, to continue the Insolvency Act till the end of next Session, 271. Carried, 272. House goes again into committee, 273, 317, 319. Motion that Mr. Speaker do now leave the Chair ; Amendment moved, expressing the opinion of the House that the Administration should advise His Excellency to disallow the Acts passed by the New Brunswick Legislature last Session relating to the Common School Act of the previous Session, to enable parties aggrieved by that Act to bring the question of its legality before the Judicial Committee of the Privy Council in England, 345. Carried, 347. House goes again into Committee of Supply, 348, 353. Report several series of Resolutions, 355, 356, 358, 361, 362, 370, 371, 372, 374, 375, 377, 378. The Resolutions agreed to, amendments being proposed and negatived (or withdrawn) to those relating to the Dominion Police, 356,—Culbute Canal (Ottawa River), 362,—Fisheries, 371,—Pacific Railway Survey, 379,—and York Roads, 380, 381. Resolution respecting postage of
