

Hereupon the Managers went to the conference:

And being returned,

Mr. *Mabey* reported the substance of the conference to the House.

On motion, the House resolved itself into a committee of the whole House, to resume the consideration of the amendments to the Bill intituled "An act to ascertain and establish the Boundary Lines of the several Counties and Townships of this Island—and to regulate the duty of Surveyors."

Mr. McNeill, Chairman of the Committee, reported, that they had gone into the consideration of the business to them referred, and that the Committee had directed him to report that they recommend that a conference be held with the Council on the subject-matter of the said amendments.

Ordered, that the Report of the committee be agreed to.

Resolved,—That a conference be requested with the Council, on the subject-matter of the said amendments, in conformity with the Report of the Committee.

Ordered, that Mr. *Mabey*, Mr. *McNeill*, Mr. *Owen*, and Mr. *Fairbairn* be a Committee to manage the said conference.

On motion of Mr. *Brecken*—

Resolved,—That an humble Address be presented to the Lieut.-Governor, praying that his Excellency will be pleased to appoint Commissioners to join the Committee appointed by this House to examine the Statute Book, previous to its being re-printed, and report to the House early in the next Session their opinion as to what Laws are become obsolete or inefficient.

Ordered, that Mr. *Brecken*, Mr. *Mabey*, and Mr. *Owen* be a committee to prepare the said Address.

On motion of Mr. *Dalrymple*—

Resolved, that the House do this evening go into a Committee of the whole House, on the consideration of Supplies to be granted for the public service.

On motion, the House resolved itself into a Committee of the whole House, to resume the consideration of all matters relating to Roads and Bridges.

Mr. Speaker resumed the chair.

Mr. *Cameron*, Chairman of the committee, reported, that the committee, having considered of the matters referred to them, do report thereupon as follows:—

Your Committee have had under consideration the Lieut.-Governor's Message relative to the Appropriation of Monies for the service of Roads and Bridges for the present year; the several Returns of the Road Commissioners, and numerous Petitions from different parts of the Island for aid for Roads, Bridges, &c. and also the Petitions to the Lieut.-Governor, on the same subject, and recommended by him to the consideration of the House.—With reference to the Appropriations for Roads and Bridges, the Committee have made a clear statement of all the former Appropriations which remain unexpended, with the additions deemed necessary—and have carried both into a column, shewing at one view the whole intended expenditure on that branch of the Public Service for the present year, and beg leave to recommend that it be applied in the following manner:—
