Resolution adopted, 560. Bill No. 336 (Mr. Mackenzie)—An Act to amend the Veterans' Land Act, 1942; 1st R., 560. 2nd R., 568-9. Progress reported from Committee of the Whole, 569. Committee to sit again later this day, 569. Committee resumed, 569. Consideration interrupted by appeal (Mr. Pouliot) against a ruling of the Chairman, 569. Ruling reported to House and sustained, on division (yeas 113; nays 10), 569. Consideration resumed, 570. Bill reported without amendment, 570. 3rd R., 570. Passed by Senate, 694.
