House in committee on Bill (No. 69) to establish and provide for the government of the province of Alberta.—Sir Wilfrid Laurier.

On section 12, distribution of seats.

Mr. R. L. BORDEN. I gave a copy last evening to the Prime Minister of a further amendment which I propose to move. For the present I will not speak upon it as my hon, friend from St. Antoine (Mr. Ames) who is leaving this afternoon desires to make some observations. The amendment is as follows:

That section 12 be struck out and the following substituted therefor:
12. (1) Until the said legislature otherwise

12. (1) Until the said legislature otherwise provides the legislative assembly shall be composed of twenty-five members to be elected to represent the electoral divisions hereinafter defined.

(2). The expression 'federal electoral district' where used in this section means an electoral district as established by and under the provisions of 3 Edward VII., chanter 60

the provisions of 3 Edward VII., chapter 60.
(3) (a) The federal electoral district of Alberta shall be divided into five electoral divisions, each of which shall return one member.
(b) That portion of the federal electoral dis-

(b) That portion of the federal electoral district of Calgary comprised within the limits of the province of Alberta shall be divided into-six electoral divisions, each of which shall return one member.

(c) That portion of the federal electoral district of Strathcona comprised within the limits of the province of Alberta shall be divided into six electoral divisions, each of which shall return one member.

(d) That portion of the federal electoral distict of Edmonton comprised within the limits of the province of Alberta shall be divided into six electoral divisions, each of which shall return one member.
