# Hon. WM. PUGSLEY:

1. Work started August 17, 1908. Dredge

ceased operations October 29, 1908.

2. First contract by letter of superintendent of dredging to the company, dated August 10, 1908, authorizing company to commence work provided they would accept the lowest price per cubic yard, scow measurement, to be obtained by tenders, which were then being called for. Formal contract being executed by the contractors. November 6, 1908; by the department November 23, 1908.

3. November 20, 1908. Delay in passing order in council was due to the fact of the chief engineer requiring reports of experts independently of the resident engineer as to the value of the work before recommending the execution of a contract agreeing to pay the tender price of 90 cents per yard. These reports were made by the late W. J. Mc-Cordock, superintendent of dredging, and J. K. Scammell, resident engineer at St. John, and were only received in October, the last one—that of Mr. Scammell—being dated October 19.

4. No.

5. The company was asked if they would accept an extension of their contract last spring in case an order in council was passed granting such extension.

6. Verbal. By myself to the president or one of the directors of the company, and,

### SALMON RIVER POSTMASTERSHIP.

4. Petitions were received on or about the 9th November last, in one of which a Mr. H. J. Foley was recommended. The other asked for the establishment of a post office at some distance from Salmon river, which would involve either a change in the location of the Salmon river post office or the establishment of another post office in too close proximity to the Salmon river office. No action has been taken on these petitions.
5. A decision has not yet been made in

the matter.
