particular period, I think we could handle the matter all right. As it is now we would have to go to every military district in Canada, as well as to Newfoundland, to get the information for which he asks.

Question dropped.

1. In view of the rumoured danger of the development of a shortage of wool in Canada, will the minister tell the house what steps his department has taken to prevent the slaughter

2. What steps have been taken to import suitable breeding stock?

3. What steps have been taken to assist,

through advances of credit or otherwise, those who would go into the sheep business?

4. What has been done in the way of guaranteeing and stabilizing prices of wool and mutton over a period of years?

Mr. GARDINER:

1. No steps of the nature indicated have as . yet been taken to avoid the possible development of a shortage of wool in Canada. The Canadian wool situation is at present being considered by the Department of Agriculture and the Wool Administrator in consultation with representatives of the sheep industry.

*INTERNED ANTI-FASCISTS

Mr. QUELCH:

Has the government taken any action to investigate the cases of interned anti-fascists, on their own individual merit, to the end that those held merely on the charge of having been members of the communist party, may be released?

Mr. St. LAURENT: No persons have been interned as anti-fascists, nor are any being held as such. The cases of all internees under regulation 21 of the defence of Canada regulations who have requested a rehearing, or for whom such a request has been made, have been or are being investigated by advisory committees, on the individual merits of each, to the end that each may be dealt with by the Minister of Justice in view of the recommendation of the committee.
