Would the minister suggest to those responsible for the public affairs and news programs in the Canadian Broadcasting Corporation, in view of the fact that a seven day truce is likely to take place soon in the Viet Nam war, that the C.B.C. might likewise declare a seven day truce in the flood of "hate the United States" propaganda that issues forth daily from that organization. I might also suggest that such a seven day remission might be a suitable centennial project as a gesture of good will to our good friends to the south.

## EXTERNAL AFFAIRS

NORTH VIET NAM-USE OF FUNDS GIVEN FOR AID

On the orders of the day:

Mr. Eldon M. Woolliams (Bow River): I wish to direct a question to the Prime Minister. He may be able to answer the question, or he may have made some research into the matter I raised on January 19. To review my question, it referred to \$50,000 of aid to Viet Nam of which 90 per cent was going to North Viet Nam, to the Viet Cong, for purposes other than to assist civilian victims. I said I had seen the report that made this statement. Has the Prime Minister anything to report on the matter now?

Right Hon. L. B. Pearson (Prime Minister): Mr. Speaker, the position in respect of the matter referred to by my hon. friend in his question was set out by the Secretary of State for External Affairs on April 19 last in reply to a question by the right hon. Leader of the Opposition. In brief, that reply was that there was no obstacle to the transfer of funds to North Viet Nam or similar destinations, provided appropriate arrangements could be made through banking channels. As regards permission for the shipment of medical and other supplies, these come under the provisions of the Export and Import Permits Act. However, as far as medical supplies are concerned the act does not require the issue of a specific licence provided the drugs are of Canadian origin and are being sent in individual dosage form.

As to the second aspect of the question, concerning the use made of supplies or funds sent to North Viet Nam once they have reached their destination, we have no knowledge in that regard and I doubt whether the Mr. David Orlikow (Winnipeg North): My government of North Viet Nam would regard Minister of Finance.
