## AIR CANADA

SUGGESTED INTERVENTION BY  
FEDERAL MEDIATOR

On the orders of the day:

**Hon. Michael Starr (Ontario):** Mr. Speaker, I should like to ask the Minister of Labour whether or not he has received a report from the private mediator in the Air Canada dispute and, if so, whether a decision has been reached by the government to appoint a federal mediator to bring about a solution?

**Hon. J. R. Nicholson (Minister of Labour):** Mr. Speaker, as I announced in the house yesterday in answer to a question, I received a copy of a letter not a report from the chairman of the mediating group. I have now had an opportunity to consider it and discuss it with my staff. We do not intend to intervene at this time by appointing a mediator.
