EXCISE TAX ACT

The House proceeded to the consideration of a ways and means motion to amend the Excise Tax Act.

Hon. Herb Gray (for the Minister of Finance) moved:

That it is expedient to introduce a measure to amend the Excise Tax Act to provide

- (1) that a tax of five per cent be imposed on each amount paid or payable in Canada for transportation of a person by air where such transportation
- (a) begins at a point in Canada and ends at a point in the taxation area,
 (b) begins at a point in the taxation area outside

Canada and ends at a point in Canada, or

(c) begins at a point in the taxation area outside Canada and ends at a point in the taxation area outside Canada.

(2) that a tax of five dollars, or such lesser amount not less than two dollars, as the Governor in Council may determine, be imposed on each amount paid or payable in Canada for transportation of a person by air where such transportation begins at a point in the taxation area and ends at a

point outside the taxation area,
(3) that the expression "taxation area" shall mean Canada, the United States (except Hawaii) and the

islands of St. Pierre and Miquelon, and

(4) that the legislation based on this resolution shall come into force on a day to be fixed by proclamation.

Motion agreed to.
