CANADIAN CONSTITUTION

PURPOSE OF TRIP BY MINISTER OF JUSTICE TO LONDON

STUDY OF FORMULA TO AMEND CONSTITUTION— UNANIMITY OF PROVINCES

Hon. Martial Asselin (Charlevoix): Mr. Speaker, I have a supplementary question I wish to direct to the Acting Prime Minister.

Could he tell this House, considering a lack of consensus on the part of the provinces on the new amending formula, whether the federal government has decided to delete from the Victoria conference agenda any consideration of the amending formula, in such a way that the discussions would deal only with the repatriation of the Canadian constitution?

Hon. Mitchell Sharp (Acting Prime Minister): Mr. Speaker, it is not my understanding that the differences among the provinces and the federal government are such that they would interfere with the accomplishment of a fundamental reform of the constitution. The Canadian government is proceeding on the basis that there is a wish and, indeed, a desire to accomplish this fundamental reform that was discussed at the last meeting.

BARLEY-ALLEGED HIGHER PRICE TO EASTERN FARMERS

The Canadian Wheat Board is said to have recently sold for export 100,000 tons of feed barley at a price of 93 cents a bushel, F.O.B. Churchill, and my question is: Why do Eastern Canada cattle farmers always have to buy their feed barley at a price higher than that set by the Canadian Wheat Board for export purposes?

It is not normal to comment on the sale price of a particular sale of barley. Of course, from time to time prices do vary on the basis of different ports and destinations, and transportation costs to the interior of Canada are certainly different from those simply out of Churchill.
