Hon. Ron Basford (Minister of State for Urban Affairs): Mr. Speaker, the position is that we are sharing a very substantial portion of income taxes with the provinces and they are free, under the constitution, to make what arrangements they wish with their municipalities. The province of Ontario, for example, which takes the lowest percentage of any province in Canada of the personal income tax, could by bringing that percentage up to the national average of the other provinces raise by that one simple step \$300 million for its municipalities.

## ALLEGED OVERCHARGING BY BANKS ON FISHERIES IMPROVEMENT LOANS—GOVERNMENT ACTION

## SUGGESTED FEDERAL SUPPORT FOR CITY OF OTTAWA PLANNING

## EFFORTS OF GOVERNMENT TO ASCERTAIN POLICY OF ARAB OIL PRODUCING STATES TOWARD CANADA

Hon. Robert L. Stanfield (Leader of the Opposition): Mr. Speaker, my question is directed to the Secretary of State for External Affairs and arises out of the information given by the Minister of Energy, Mines and Resources about our present position vis-à-vis oil shipments from the Middle East. Can the Secretary of State for External Affairs indicate what country diverted a vessel destined for Canada and what he is doing, through diplomatic channels, as indicated by the Minister of Energy, Mines and Resources, to determine what the policy of the Arab oil producing countries is toward Canada?

Hon. Mitchell Sharp (Secretary of State for External Affairs): Mr. Speaker, the Minister of Energy, Mines and Resources gave me this information just a very short time before the House assembled at two o'clock. He informed me that it was a shipment which had been held up by Saudi Arabia. We are not sure yet what the significance of this action may have been. I have given instructions to my department to ask the ambassadors from all the Arab states who are accredited and resident in Ottawa to call on me.
