**INTERIM SUPPLY**

**Mr. Speaker:** The motion is by Mr. Cullen, for Mr. Andras, seconded by Mr. Whelan, that this House do concur in interim supply as follows. I would hope that these two pages of rather detailed figures have been made available for examination by hon. members and I may dispense with the reading of the motion, and that it will be printed as having been read.

**Some hon. Members:** Agreed.

**Hon. Bud Cullen (for President of the Treasury Board)** moved:

That a sum not exceeding \$5,657,022,492.00 being the aggregate of:

(a) three-twelfths of the total of the amounts of the items set forth in the Estimates for the fiscal year ending March 31, 1979, laid before the House of Commons on February 22, 1978, \$5,188,330,365.50;

(b) an additional eight-twelfths of the total amount of Energy, Mines and Resources Item L65, External Affairs Item L15, Indian Affairs and Northern Development Items L40 and L45, Transport Item 90, Treasury Board Items 20 and 35 and Urban Affairs Item 20 (Schedule A) of the said Estimates, \$64,618,666.67;

(c) an additional six-twelfths of the total amount of Secretary of State Item 70 and Treasury Board Item 10 (Schedule B) of the said Estimates, \$75,050,000.00;

(d) an additional five-twelfths of the total amount of Treasury Board Item 5 (Schedule C) of the said Estimates, \$83,333,333.33;

(e) an additional four-twelfths of the total amount of Finance Item 5 (Schedule D) of the said Estimates, \$45,666,666.67;

(f) an additional three-twelfths of the total amount of Communications Item 1 and Secretary of State Item 45 (Schedule E) of the said Estimates, \$28,786,500.00;

(g) an additional two-twelfths of the total amount of Energy, Mines and Resources Item 10 and External Affairs Item 5 (Schedule F) of the said Estimates, \$97,250,500.00;

(h) an additional one-twelfth of the total amount of Energy, Mines and Resources Item 20, Finance Item 1, Indian Affairs and Northern Development Item 5, Privy Council Item 1, Supply and Services Items 1 and 15 and Transport Item 20 (Schedule G) of the said Estimates, \$73,986,459.83;

be granted to Her Majesty on account of the fiscal year ending March 31, 1979.

**Mr. Speaker:** Is it the pleasure of the House to adopt the said motion?

**Some hon. Members:** Agreed.

Motion agreed to.

**Mr. Cullen (for President of the Treasury Board)** moved that Bill C-31, for granting to Her Majesty certain sums of money for the public service for the financial year ending the 31st March, 1979, be now read a first time and be printed.

**Mr. Speaker:** Is it the pleasure of the House to adopt the said motion?

**Some hon. Members:** Agreed.

Motion agreed to, bill read the first time and ordered to be printed.

**Mr. Speaker:** Shall I call it six o'clock?

**Some hon. Members:** Agreed.
