**"OPTION NORTH" PROJECT**

**Question No. 377—Mr. McIsaac:**

1. Under the Canada-Saskatchewan Interim Subsidiary Agreement on the Saskatchewan Northlands, what amount of federal funds have been allocated to the "Option North" project?

2. (a) What are the titles of the various sub-projects (b) what amount of federal funds was expended to date, in each case (c) how many persons were assisted under each sub-project (d) what share of the total cost of the sub-projects is represented by the federal contribution?

**Mr. Donald Wood (Parliamentary Secretary to Minister of Regional Economic Expansion):** The reply for the Department of Regional Economic Expansion is as follows: 1. Under the Canada-Saskatchewan Interim Subsidiary Agreement on the Saskatchewan Northlands, from April 1, 1974 to March 31, 1977, \$951,000 of federal funds has been allocated to the "Options North" Project.

2. The titles of the various sub-projects, the amount of federal funds expended to date, and the number of persons assisted under each sub-project are listed in the following table.

(d) The federal contribution to each of the sub-projects is sixty per cent.

Footnote 1— Indirect benefit was provided to students of the West Side Community College at Beauval under the Community College Development sub-project. As well, residents of the West Side and LaRonge regions of northern Saskatchewan would receive indirect benefit.

Footnote 2— A study called "Options North—A General Program Outline" was undertaken under this sub-project. The results of the study have an indirect impact on the 750 persons who are directly exposed to the sub-projects on training (items 3 to 7 inclusive).
