CALL FOR IMPLEMENTATION OF FIXED INTEREST RATE POLICY FOR FARMERS—MOTION UNDER S.O. 43

Mr. Girve Fretz (Erie): Madam Speaker, aside from the great depression it is impossible to recall a time when Canadian agriculture has suffered such severe and devastating harm, and it is all due to the government's economic mismanagement. Farmers are dependent upon credit, and the high interest rate policy pursued by the Minister of Finance (Mr. MacEachen) has pushed farmers to the wall, to the point where farm bankruptcies have increased 139 per cent in two years. In light of this I move, seconded by the hon. member for Lethbridge-Foothills (Mr. Thacker):

That the Minister of Finance make long-term capital at a fixed rate of interest available to farmers.

APPLICATION OF DEVELOPMENT BOND PROGRAM—MOTION UNDER S.O. 43

That this House request the Minister of State for Small Businesses and the Minister of Agriculture to issue releases immediately to the financial and small-business communities clarifying the changes to the SBDB as they now relate to both small businesses and small farms.
