Therefore I am reluctant to take too restrictive a stance in such a way as to frustrate the operation of the rule, for I have said in the past that if a rule is on the books it obviously means there are occasions on which it must be permitted to precipitate a discussion. Yet, in order to do so, I am called upon to make a value judgment, it seems to me, as to whether or not a situation is an emergency.

I am faced today with exactly the same necessity, that is, to make a value judgment in this case, and, while I recognize that any one of the elements referred to might be considered chronic, I recognize also the added relevance of the juxtaposition of a number of such elements in the applications before me.

Additionally, I am required to have regard, and this is perhaps not as strong as the conditions laid down by the Standing Order, to the probability of the matter coming before this House within reasonable time. We are adjourning tomorrow and there will be no opportunity to debate this matter, as was possible in different circumstances and when I had to look more restrictively at subsection (16)(a) of the Standing Order. I am, therefore, inclined in these circumstances to give the benefit of the doubt to the member and to accept the application of the hon. member for Oshawa whose notice I received first.

Does the hon. member have leave to proceed?

Some hon. Members: Agreed.

Madam Speaker: Therefore the hon. member will be allowed to proceed at 8 p.m. this evening.
