## Petitions

Mr. Benjamin: Point of order.

Mr. Deputy Speaker: The Hon. Member is seeking to reflect on a judgment of the Chair. I call to his attention that this is not permitted. The Hon. Member for Regina East.

Mr. Benjamin: Mr. Speaker, the Chair informed the House that it would only recognize—

Mr. Deputy Speaker: Would the Hon. Member please sit down? The Chair recognizes the Hon. Member for Regina East.

Mr. Benjamin: Another point of order.

Mr. Nielsen: He may have a new point of order. He might.

Mr. Benjamin: Point of order. I know, with all due respect, that the Chair would never countenance or take part in changing the rules in the middle of a procedure.

Mr. Axworthy: Order.

Mr. Deputy Speaker: The Hon. Member is reflecting on a judgment of the Chair.

Mr. Benjamin: Exactly.

Mr. Deputy Speaker: He has repeatedly done this.

Mr. Benjamin: Exactly.

Mr. Deputy Speaker: The Chair does not feel obligated in the circumstances to recognize him again on the same point of order on which a ruling has been made. The Chair now recognizes the Hon. Member for Regina East.

If the Hon. Member for Yukon (Mr. Nielsen) has an observation, the Chair is always prepared to listen. But the Chair is asking in the circumstances if the Hon. Member for Regina East can be recognized. The Hon. Member for Yukon wishes to be recognized.

Mr. Nielsen: The only observation I have to make, and I do not want to appear to be bailing out the NDP, is that I did not hear enough of the point of order of the Hon. Member for Regina West, even though it is not my responsibility to do so. I heard one sentence. It may well be that he is going to get into an area reflecting on the judgment of the Chair and the Chair at that point would be quite correct in curbing it. But I can think of a point of order he could raise legitimately—

Mr. Deputy Speaker: With all due respect to the Hon. Member for Yukon, we cannot deal in hypothetical situations.

Mr. Nielsen: Let us hear it.

Mr. Deputy Speaker: The Hon. Member for Yukon is an experienced Parliamentarian, and the Hon. Member for Regina East has been recognized for the purpose of petitions.

Mr. Nielsen: He has a point of order we have not heard, for heaven's sake.

Mr. Deputy Speaker: Four times we have heard it.
