Monday morning. Surely the Prime Minister can answer that question now, and he ought to.

An Hon. Member: Yes or no.

An Hon. Member: The whole truth.

Hon. Michael Wilson (Minister of Finance): Mr. Speaker, the Hon. Member knows that it is not the practice of this Government, or any other Government, to say these are the various things that were discussed in a confidential meeting.

An Hon. Member: That is outrageous.

Mr. Wilson (Etobicoke Centre): What is important is the decision that was taken by the Government—

Mr. Frith: You misled the House on Monday.

Mr. Wilson (Etobicoke Centre): —is well known to the Hon. Member and to other Hon. Members. That decision was based on the range of information we had at the time. It was based on the results of discussions that we had had both with officials as well as the banking community. It was the best decision we could have taken based on the information that was available.

An Hon. Member: A question.
