PRESENTATION OF SECOND REPORT OF STANDING COMMITTEE

Mr. Felix Holtmann (Selkirk—Interlake): Mr. Speaker, pursuant to Standing 96(2) I have the honour to present the

second report of the Standing Committee on Government Operations, in both official languages.

The report addresses itself to concerns regarding Canada Post's future plans for small rural post offices. The committee is of a strong view that Canada Post will not solve its fiscal problems by closing rural post offices or changing rural postal service.

Some Hon. Members: Hear, hear!

Mr. Holtmann: Canada Post should look elsewhere for savings in its operating budget. No closures of rural post offices or change in postal service should be undertaken without meaningful consultation or consent of the community affected.

Some Hon. Members: Hear, hear!

Mr. Holtmann: The local Member of Parliament must have the option of being an integral part of the consultation process and must be informed immediately of any closures or changes in rural post office services.

The committee intends to continue to exercise its mandate under Standing Order 96(2) to review and to report to the House from time to time on the operational plans of Canada Post

A government response is requested under Standing 99(2).

On behalf of the committee I wish to express my appreciation for the co-operation of the Minister responsible for Canada Post who met with the committee. I also wish to acknowledge the contribution of the witnesses who appeared before it.

I also take this opportunity to thank the representatives of all three Parties for their efforts in drafting this unanimous report in the true spirit of parliamentary reform.
