5. No person other than a licensed butcher, shall slaughter for sale any Ox, &c.

within the liberties of the city.

6. Butchers and others to sell fresh meat in the Public Markets, and not elsewhere. Farmers, however, may dispose of such, being the produce of their farms, by the quarter, or greater quantity, in any part of the city, after 12 o'clock, having first paid the market fees.

7. No person, except a licensed butcher or farmer as aforesaid, can sell in any

part of the city or public markets any fresh meat.

8. Butchers shall not, by themselves or agents, purchase or cause to be purchased from farmers or others, meat or other articles of provison, before 12 o'clock noon, for the purpose of selling the same again, nor shall any butcher, &c. act as the servant, &c. of others in the purchase of meat or other provisions before the hour aforesaid.

Relate to the fees and rent to be paid by butchers for their license and

rent of stalls.

11. Requires all persons selling meat or provisions by weight or measure, to be provided with scales, weights and measures, duly adjusted by the Inspector of weights and measures, and if found deficient to be forfeited to the use of the poor, and if sold, seller to be punished as provided.

12. No person to drive inside the market faster than a walk.

13. Horses, Cattle, &c. excluded from the interior of the market and sidewalks around the same; horses or oxen drawing vehicles into the market to be immediately taken out of the same until again wanted to draw them off. Vehicles with produce for sale to be placed as the market clerk shall direct.

14. Waggons, &c. oringing firewood into the city for sale, shall be placed along the south side of Front-street, east of Church-street, to be under the direction of the clerk of the wood market, and not to loiter about the streets with their load.

15. Vehicles bringing hay or straw to market for sale, to be stationed at the hay market, east of the market-square, and to be under the direction of the clerk of

the weigh-house, and not to loiter about the streets.

16. Market-place to be open daily, (Sundays excepted) at 5 o'clock, a. m., between the 1st of May and 1st of November, and at 7 a.m. the rest of the year; to be closed daily throughout the year at 4 o'clock, p. m., except on Saturdays, when it is open until 9 p.m. Butchers to have liberty of opening their stalls to supply steamboats arriving after market hours.

17. Clerk of the market to assign places to hucksters, and to report all infractions of the market laws to the clerk of the Common Council, whose duty it is to prose-

cute all such offenders.

18. Clerk of the market to inspect all meat and provisions offered for sale, and under the directions of any Alderman seize and destroy such as may be tainted or

unfit to be eaten.

19. The square of the market on the Bay shore to be the only place in the city or liberties where wheat, barley or other grain, and flour and meal is to be exposed for the purpose of being bought or sold; persons buying or selling elsewhere before 12 o'clock noon, are liable to punishment; persons, however, having stores or warehouses can sell wheat and flour in the usual way; and farmers, after 12 o'clock noon, can sell wheat, &c. in any part of the city, having first been at the regular market place and unable there to dispose of the some-nothing in this clause to

interfere with the privileges granted to St. Patrick's market.

20. None of the shops, stalls, &c. in the public market to be underlet or left in charge of any one by the owners thereof, without the written permission of the

Chamberlain of the city.

21. Farmers or others not permitted to dispose of any article of provision usually sold in the market elsewhere in the city, until after having been at one of such

regular market places, and paid the fee hereinafter mentioned.

22. Clerk of the market to demand and receive the following fees, viz: from the owner of every sleigh, waggon, &c. containing fresh meat for sale, 71/2d.; from the owner of every two-horse waggon or sleigh, containing produce or other articles of provision for sale, 71/3d.; if by a one-horse cart, sleigh or cutter, 4d.; if on horse-back or wheel-barrow, 3d.; if by hand, 1d.; and 71/3d. for every load of lumber or shingles brought to the city or liberties for sale. Persons neglecting or refusing to pay the aforesaid fees are subject to the penalties hereinafter mentioned, 23. Persons guilty of any infraction of the provisions of the above act, on con-

viction before the Mayor or presiding Alderman, are liable to a penalty not exceeding five pounds, nor less than 5s. and costs; and in default of payment, in case no sufficient distress be levied, liable to imprisonment for any period not

exceeding one calendar month.
