## FEW HOURS AFTER HIS WIFE IS BURIED

Portage Vale, Kings Co., Jan. 26.—The people of this place were shocked on last Saturday when the sad news arrived that Mrs. Wm. Snyder had suddenly passed away on Friday night at the home of her brother, Charles Holmes, Hill Grove, Westmorland Co., and it was only a brief space of time before another sad report came, stating that Mr. Snyder had died on Sunday evening, the day Mrs. Snyder's mortal remains were laid away in the churchyard at Hill Grove.
