

LIMITS AND CLERKS OF DIVISION COURTS OF THE COUNTY OF KENT.

1st. Consists of the Town of Chatham, the Township of Raleigh, East Tilbury and Romney, and those parts of the Townships of Harwich, Chatham and Dover East, not included in the Third, Fourth and Fifth Divisions. Clerk, Thomas Glendenning.

2nd. Consists now of what formerly was the Seventh Division, and embraces all the Township of Howard, South of the Seventh and Eighth Concession lines, and that part of Harwich South of the line of Talbot Street. Clerk, John Duck.

3rd. Consists of Camden, with the exception of Tecumseth Village, and that part East of Number one, Concession B. and South of the base line of Camden aforesaid; also, all that part of the Township of Chatham East of the Lindsay Road; also, the Gore of Camden, and that part of Dawn formerly attached to the County of Lambton. Clerk, David Wallace.

4th. Consists of that part of Howard North of the line between the Seventh and Eighth concessions; all the Township of Harwich North of Talbot Street, and East of the communication road, excepting that part of the same North of the Fourth concession of Harwich from the Thames, and West of said road. Clerk, George Young.

5th. Consists of Dover West, Dover East, North of the Fourth concession; also, that part of the Township of Chatham North of the Eighth concession; also, the Gore of Chatham, and also includes that part of the Township of Sombra, formerly attached to Lambton. Clerk, Robert Mitchell, John Lillie, Jr., Deputy.

6th. Consists of the Township of Zone, the Northern part of Orford, now included in the Eighth Division, and also that part of Camden, not included in the Third Division. Clerk, John Taylor.
