**Fallen Pictures Omen**  
 The townspeople of Milton Regis, Kent, are discussing singular happenings. When Mr. Littlewood had the first stroke four years ago his portrait in

**Infirmity Patient's Money**  
 The Master of Donegal Workhouses has handed over to an administratrix of Hugh McKane, who recently died in the infirmary, a sum of £66 6s. 4d.

**Young Cyclist's Death**  
 While cycling from Kells to his home, a lad of twelve, son of Mr. Philip Condra, a farmer, residing at Possetown, near Ardee, was noticed to grow weak, and dismounting from his bicycle, sat on the roadside to rest, but succumbed almost immediately. Death is believed to be due to heart failure.

**Boat in a Gale**  
 When out in a motor-boat off Lough Corrib Mr. Woolner, an English visitor, with his wife, niece and daughter of a friend, were caught in a fierce gale, and only reached the island of Inishgill with the greatest difficulty. Owing to the wildness of the weather and the roughness of the sea they were unable to leave the island for two days.

**Relic of Siege of Derry**  
 Mrs. Courtney, late of Warrenpoint, while on a visit to some friends at the residence of the late Mr. James Ash, Faughanvale, County Derry, found a small silver-mounted cup of antique pattern which would appear to have belonged to the family or descendants of Colonel Sir Thomas, who was one of the commanders in Derry during the siege.

**Married Six Times**  
 Charles Gibson, an excursionist from Belfast, was charged at Dublin with having committed an assault on an old man named Michael Coyne, aged eighty-three, employed as a turnstile attendant in the Zoological Gardens. Mr. J. G. Lidwell, who defended said the old man had been six times married, and was of a very quick temper. Mr. Mahony said the old man's domestic complications account for a certain irascibility of temper, but at the same time he had been very seriously injured, and the accused would be returned for trial, bail being allowed.

**Illicit Whiskey**  
 Penalties of £100 each, with an additional fine of £50 in the case of one defendant who was alleged to have obstructed the Excise officers and police, were imposed on two farmers at Dromahaire, County Cork, on Tuesday.  At a meeting of Limerick (Clare division) District Council, replying to strictures by the Local Government Board Auditor with reference to rent collection, Mr. O'Dwyer said the council had reduced the rents of laborer's cottages from 13d to 11d per week, but the auditor kept calculating them at the old rent, thus accounting for the arrears, which had given rise to the comment in his report.

**Father's Pathetic Appeal**  
 The Mullingar Board of Guardians refused an application, couched in pathetic terms, from Owen Carey for permission to take his daughter out of the Summerhill Industrial School, Athlone.
