#### MAN DAYS LOST, 1962

### Question No. 378-Mr. Beaule:

1. How many man days were lost last year because of labour disputes?

2. How many man days were lost last year because of unemployment?

Mr. Byrne: 1. There were 311 strikes and lockouts in Canada during 1962. These work stoppages involved 74,332 workers for a total of 1,417,900 man days.

2. The average number of unemployed persons in 1962 was estimated to be 391,000. On the basis of 250 working days per year, the total working time lost through unemployment in 1962 was 97,750,000 man days.

## TORONTO-ASSISTANCE FOR SLUM CLEARING PROJECTS

# Question No. 392-Mr. Scott:

In each of the years 1959, 1960, 1961, and 1962, were any requests received by the government from the city of Toronto or the municipality of metropolitan Toronto for financial assistance for slum clearance projects in the city of Toronto and/ or the municipality of Toronto and, if so, in each of the respective years (a) what requests were received (b) for what purposes (c) in what particular areas (d) how much money was committed by the government for these projects (e) what are the particulars of each project, the area, and the amount involved?

Mr. Garland: A request from the city of Toronto for federal assistance under the National Housing Act for a slum clearance project was received in 1959 followed by a similar request in 1960.
