R.C.M.P. INVESTIGATION INTO DOCUMENT TAMPERING, B.C.

Question No. 2,764-Mr. Howard:

1. Was the R.C.M.P. requested to investigate an allegation that the Royal Bank of Canada, or any of its branches or employees, altered, tampered with or otherwise changed a document signed by one L. D. Tipton of Francois lake, B.C., to indicate that the signature was on behalf of a limited company and to make it appear that the document was signed on February 26, 1964 instead of on March 19, 1964?

2. What action has the R.C.M.P. taken with respect to this request?

Mr. D. S. Macdonald (Parliamentary Secretary to Minister of Justice): 1. Lorenzo D. Tipton complained to the Burns Lake detachment, R.C.M.P., with respect to the forgery of a document which he claimed had been forged by officials of the Royal Bank of Canada. Tipton was interviewed by a member of the R.C.M.P. at Burns Lake. He advised that all documents were in the hands of his solicitors, that these solicitors were taking necessary steps to bring the matter before the courts, and that they, the solicitors, wished that any action with respect to Tipton's complaint be held in abeyance.

2. The solicitors indicate that the whole matter is subject to civil action and, therefore, no action can be taken by the R.C.M.P. with respect to the complaint. If criminal action is involved it comes within the jurisdiction of the attorney general's department for British Columbia.
