## AIR TRANSPORT

POSSIBLE STRIKE OF TRAFFIC CONTROLLERS-SAFETY OF TRAVELLERS

Mr. J. H. Horner (Crowfoot): Mr. Speaker, I have a question for the Minister of Transport. In view of the breakdown of negotiations between the federal government and the air traffic controllers, will the minister assure the House that adequate contingency plans have been made to ensure that the safety of people travelling by air will not be jeopardized, perhaps through the inexperience of those taking the places of the air traffic controllers?

Hon. Donald C. Jamieson (Minister of Transport): I can give an unqualified assurance that such is the case, Mr. Speaker.

Mr. Horner: Did the Minister of Transport not assure the Public Service Staff Relations Board on July 29, 1969, that in the event of a strike movement by air would cease?

Mr. Speaker: Order, please. The hon. member's supplementary question is argumentative.

Mr. Horner: May I rephrase it, Mr. Speaker? I certainly did not intend to argumentative.

Some hon. Members: Oh, Oh!

Mr. Horner: I was only seeking clarification of the statement the minister made on July 29. Did he not state that in the event of a strike air traffic would cease? I am asking for clarification, not for an argument.

Mr. Jamieson: With the greatest respect. I have to say that the question is hypothetical. There is no strike. I re-emphasize that in no circumstances will we in any way compromise public safety. I am sincerely hopeful that the necessity to make this kind of decision will not arise because a strike will not take place.

Mr. J. M. Forrestall (Dartmouth-Halifax East): May I ask whether the contingency plans involve the staffing of both air traffic control centres and local air traffic positions with supervisory personnel?

Mr. Jamieson: The details will depend on [Mr. Godin.]

whatever steps are necessary to protect the public interest and public safety. As for the specific measures used, they will to a large measure depend upon the outcome of the negotiations and the situation which prevails thereafter.

Mr. Forrestall: Can the minister assure the flying public that these very vital posts will not be filled by supervisory personnel?

Mr. Jamieson: I cannot give that kind of assurance. I can only say they will be filled, if they are filled at all, by people who will protect the public safety.

TORONTO-LACK OF REPRESENTATION AT MEETING ON PROPOSED SITE
