response. No deficiencies in braking action have been experienced on CP Rail's several types of long cars such as multi-level cars and piggyback flats that are already equipped with B-1 quick service valves.

5. (a) CP Rail problems experienced are all of the failsafe variety and have involved either the failure of train brakes to release after an application, causing the train affected to stop, or the development of brake pipe leakage to such an extent that it has been impossible to start the train out of the yard until the cause has been found and remedied. In all cases where deficiencies have occurred, corrective action has been taken which has returned the cars to service in satisfactory condition; (b) CN: There has been a problem reported on the quick service valves. However, the nature of the problem is such that it could cause delays in charging time but does not affect braking ability of a train. In any event these valves were temporarily isolated before the cars entered service. They will not be used until the problem is rectified.
