so fast that I thought it far more important to ensure that these funds be used to provide additional housing stock which should help everyone down the line.

AIR TRANSPORT

REQUEST FOR SERVICE BETWEEN EASTERN SASKATCHEWAN AND WESTERN MANITOBA—APPLICATION OF TRANSAIR FOR JET SERVICE

Hon. W. G. Dinsdale (Brandon-Souris): Mr. Speaker, I have a question for the Minister of Transport arising from the cancellation of the air service into eastern Saskatchewan and western Manitoba last January by the Air Transport Committee with the approval of the government. In light of the promise made by the Prime Minister at his famous airport conference in Winnipeg on May 23 that this service would be restored and upgraded in the interest of development and employment opportunities, can the minister inform the House when this promise will be implemented.

An hon. Member: In the next four years.

Hon. Jean Marchand (Minister of Transport): That is a fair assumption, Mr. Speaker. First, we have to buy two Saunders from the Manitoba government, something I signed for this morning, so we are in the process of achieving or realizing this promise.

Mr. Dinsdale: A supplementary, Mr. Speaker. Now that we are getting action on this matter at long last, would the minister also urge the ATC to consider immediately, or at the earliest opportunity, the application of TransAir to bring jet service into this region?

Mr. Marchand (Langelier): Mr. Speaker, the hon. gentleman knows very well the relationship between the CTC and the Department of Transport. This decision has to be taken by the Transport Committee of the CTC, not by the Department of Transport.
