AIRPORTS

PROVISION OF GARBAGE TREATMENT FACILITIES—MOTION UNDER S.O. 43

This deplorable situation unnecessarily exposes the Canadian livestock industry to risks from exotic and dangerous diseases. That the government be condemned for allowing this situation to linger and, further, that the government move immediately to construct disposal facilities for proper sterilization of all garbage left in Canada from international flights.

METRIC CONVERSION

CALL FOR DISBANDMENT OF BOARD—MOTION UNDER S.O. 43

The Canadian government notified the people of Canada through *The Canada Gazette* of February 28, 1981, that shortly only metric measurements will be permitted in retail food stores throughout Canada and that persons daring to use imperial after the said date will be liable for fines in the amount of \$5,000 and/or imprisonment of up to two years. The Government of Canada is doing this, not by an act of Parliament but by an order in council. Therefore I move, seconded by the hon. member for Lethbridge-Foothills (Mr. Thacker):

That this House orders the government to rescind immediately the said order in council, to fire the chairman and to retire the balance of the metric board.
