REQUEST FOR NEW BUDGET DESIGNED TO REDUCE  
UNEMPLOYMENT—MOTION UNDER S.O. 43

**Mr. D. M. Collette (York East):** Madam Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity, all the more urgent and pressing in view of the motion under Standing Order 43 that was introduced here this afternoon. Last week the hon. member from Winnipeg-Assiniboine (Mr. McKenzie) was quoted in *Contrast*, a Toronto black community publication, that he condones many of the racial policies of the government of South Africa. It seems the hon. member came to this incredible conclusion following a free three-and-a-half week vacation in South Africa, paid for by the government of South Africa.

Considering that the Right Hon. Leader of the Opposition (Mr. Clark) last week dissociated himself and his caucus from the remarks of the member, I move, seconded by the hon. member for York South (Mrs. Appolloni):

That in view of the lack of support of his caucus for his repugnant stand, the hon. member from Winnipeg-Assiniboine retract his statements; failing this, that this House urge the caucus of the Progressive Conservative Party to expel the member from their ranks, forthwith.

CONSULTATION URGED PRIOR TO INTRODUCTION OF  
LEGISLATION—MOTION UNDER S.O. 43

**Mr. Nelson A. Riis (Kamloops-Shuswap):** Madam Speaker, I rise under the provisions of Standing Order 43. During these times of depression level investor confidence, increasing business bankruptcies and government indecision, the Minister of National Revenue (Mr. Rompkey) recently indicated that he may again alter the terms of the small business bond. It was altered first on November 12, changed again on December 18, clarified in the latter part of January, and now is likely to be further altered. Canadians will not invest if the government continues to change the investment rules. Therefore, in an effort to establish stability and investor confidence, I move, seconded by the hon. member for The Battlefords-Meadow Lake (Mr. Anguish):

That this House urge the government to consult with parties involved in proposed legislation prior to its introduction, so that the government can avoid the embarrassment of continually having to change the rules of the game, which fuels the present climate of government indecision, instability and incompetence.
