PROVISION OF WORK PERMITS FOR SALVADORAN REFUGEES

Therefore I move seconded by the Hon. Member for Cowichan-Malahat-The Islands (Mr. Manly):

That the Government instruct all of its staff fully on the special provisions for Salvadoran refugees, give them temporary permission to work while they await the Government's decision on their fate, and add the necessary staff to the Refugee Status Advisory Committee to speed up the processing beyond the present timing of a year and a half.

UNEMPLOYMENT INSURANCE

DISQUALIFICATION OF UNEMPLOYED BRITISH COLUMBIA
CARPENTERS

That the Minister of Employment and Immigration be directed to approve the immediate payment of unemployment insurance benefits to the 120 unemployed carpenters recently laid off in Richmond, B.C.
