B.C., Status of Women News and Radio Guide have also been denied second-class mailing privileges.

Can the Government explain why *Penthouse*, *Hustler*, *Playboy* and other soft porn magazines have their mailing costs subsidized by Canadian taxpayers while a church magazine such as *Canada Lutheran* is denied that subsidy?

Mr. J. M. Forrestall (Parliamentary Secretary to Minister of Regional Industrial Expansion): Mr. Speaker, the broad area raised by the Member is under serious review and consideration. Due to the importance of the question, will he allow me to bring it to the attention of the Minister so that he can reply more fully upon his return next week?

**Mr. de Jong:** Mr. Speaker, that answer is totally unacceptable. Through its post office policy the Government is subsidizing soft porn magazines while denying church magazines that same privilege.

# REQUEST THAT COMMITTEE CONDUCT CROSS-COUNTRY HEARINGS

Mr. Simon de Jong (Regina East): I will address my supplementary question to the Deputy Prime Minister. Will the Conservative Party not allow the parliamentary committee on the Post Office to travel across the country to hear the criticisms and suggestions of Canadians in order that, through a consensus process, we can develop a plan for the Post Office which Canadians want? Canadians do not want *Penthouse* and *Hustler* to be subsidized while church magazines are not subsidized. Canadians do not want superboxes, and they do not want contracting out of rural services. Allow the parliamentary committee to travel.

Hon. Don Mazankowski (Deputy Prime Minister and President of the Privy Council): Mr. Speaker, the Hon. Parliamentary Secretary undertook to get back to the Hon. Member with regard to the first part of his question. With regard to the second part, there is a process which is normally followed for committee proceedings.

Mr. de Jong: They were muzzled. They won't even meet.

Mr. Mazankowski: These issues are decided at the steering committee level. All items which Members want to pursue at the respective standing committees are considered there. If the Member feels strongly about this particular issue, he should follow that course.
