

For Monday, December 3, 1906.

No. 1. By the Honourable Mr. Ferguson:—

November 26—That he will call the attention of the Government to an Address passed by the Legislative Assembly of British Columbia on the 12th of March last, urging the Government of Canada to establish life-saving appliances on the west coast of Vancouver island; and will inquire of the Government if any action has been taken by the Government in providing such life-saving appliances?

No. 2. By the Honourable Mr. Ferguson:—

November 26—That he will call the attention of the House to the serious loss of life caused by the recent wreck of several vessels on the north coast of Prince Edward Island, and to the absence of life-saving appliances in that locality; and will inquire of the Government if they intend taking action to provide absolutely necessary facilities to aid in the preservation of the lives of seamen on that coast?

No. 3. By the Honourable Mr. McDonald (Cape Breton):—

November 26—That he will inquire whether the Government has bought a site for a public building at Glace Bay? When? What price was paid? Was there a report made by a Government engineer respecting such a site, and were there more than one site reported on? Do the Government intend to ask for tenders for the construction of a public building soon?

For Tuesday, December 4, 1906.

No. 1. By the Honourable Mr. Ferguson:—

November 26—That he will call the attention of the House to the report of A. P. Low, B.Sc., F.R.G.S., at present Director of the Geological Survey, on the Dominion Government expedition to Hudson bay and the Arctic islands on board the Dominion steamer *Neptune* in 1903-04, especially to the valuable information therein contained, showing the feasibility of the navigation of Hudson bay and straits; and will inquire if it is the intention of the Government to promote railway construction from the wheat fields of the Northwest to Fort Churchill, and provide necessary aid to the navigation of the northern internal waters of Canada?

No. 2. By the Honourable Mr. Landry:—

November 27—That an humble Address be presented to His Excellency the Governor General; praying that His Excellency will be pleased to cause to be laid before this House a copy of all the correspondence exchanged between the Government or the Chairman of the Commissioners of the Transcontinental Railway, or any other of the said commissioners, and the different railway companies having, or about to have access, to Quebec, or any other association or body or person whomsoever, on the subject of the choice to be made, of a union, central or terminal railway station in the City of Quebec; as well as of every report whatsoever made on this subject, whether by the companies or the bodies in question, or by the aforesaid commissioners.

No. 3. By the Honourable Mr. Landry:—

November 27—That he will inquire of the Government—
Have the Commissioners of the Transcontinental Railway asked for tenders for the supply of sleepers for any part whatsoever of the Transcontinental Railway?
Who are the tenderers?
