CALL FOR PRORATA PENSIONS FOR WIDOWS WHERE VETERAN'S DISABILITY PENSION LESS THAN 48 PER CENT—MOTION UNDER S.O. 43

That this House takes note of the deep concern of all veterans' organizations with respect to the rule under which a veteran's widow receives no widow's pension unless the veteran was in receipt of a disability pension of 48 per cent or more, and this House calls on the government to correct this situation, without further delay, by providing prorata pensions for widows of veterans in cases where the veteran's disability pension was less than 48 per cent, as recommended by the Woods commission, the Hermann commission and the Standing Committee on Veterans Affairs.

REQUEST GOVERNMENT NOT GRANT FUNDS FOR QUEBEC REFERENDUM CAMPAIGN—MOTION UNDER S.O. 43

**Mr. René Matte (Champlain):** Mr. Speaker, I should also like to present a motion on a question of urgent and pressing necessity.

Considering the importance and the seriousness of the referendum on the constitutional future of Quebec;

Considering the need to let Quebecers entirely free to choose objectively the appropriate structure for their emancipation and their evolution;

Considering that the most elementary justice and simple logic should lead us to put this debate well above the chauvinism and partisanship inherent in electoralism;

Considering that it would be inadmissible for the federal government spokesmen who do not reside in Quebec to campaign directly or indirectly within the province;

Considering finally that it would also be absurd and unfair to have the taxes which are levied among Quebecers by the federal government used against their very interests;

I move, seconded by the hon. member for Témiscamingue (Mr. Caouette):

That the House order the government to stop fighting against the growing awareness of Quebecers concerning their future and consequently to abolish immediately the Tellier committee which has been created to this end.

## NATIONAL SECURITY

REQUEST FOR GOVERNMENT INVESTIGATION INTO SUBVERSIVE ACTIVITIES IN CANADA—MOTION UNDER S.O. 43
