

MIELKE AND JOHNSTONE TO MEET IN GOLF FINAL

FORMER CHAMP. AND ASHBURN DOCTOR WIN OUT

Brilliant and Daring Mark Playing in Semi-Finals Today

Canadian Press HALIFAX, N. S., July 29.—Gerald Mielke, Brighton, and former Marlborough golf champion, and Dr. J. H. L. Johnstone, will meet in the final of the Maritime Golf Championship tomorrow, as the result of this morning's play. That was decided when Mielke won out over Don McNaughton, Moncton, in a brilliant performance, and Dr. Johnstone, Ashburn, triumphed over the veteran Greenbrook entrant, H. M. Wylie.

BRILLIANT PLAY Mielke furnished the thrills in this morning's round, when, in a brilliant exhibition of golf, featured by two outstanding shots, which for brilliancy and daring have not yet been approached by any other competitor in the tournament, he defeated Don McNaughton, youthful Moncton golfer, four and three.

Mielke did the 18 holes in 75, while McNaughton took 84 for the course. The Moncton golfer was plainly nervous. He was short in his field stroke and away off in his putting. In direct contrast to his play was the performance of the former Maritime champion, Mielke played with the steadiness of a veteran. At the six hole, when almost stymied by the trees to the left of the green, he played his second shot an iron, over the trees for a beautiful shot which landed on the green, and again at the 19th he captured the playoffs of the gallery with a wonderful approach.

JOHNSTONE BEATS WYLIE Dr. J. H. L. Johnstone, Ashburn, won the right to meet Gerald Mielke in the final of the championship, when he defeated M. Wylie, Greenbrook, two up after a close and exciting match. Wylie went out in 87 to Johnstone's 86, but Johnstone played a steadier game in the way home, and triumphed over his veteran adversary.

The men are as yet unidentified. One of the men was killed when the debris cleared away. The explosion was so great that windows were shattered on the opposite side of the street, were shattered. A number of men working some distance away, were rendered unconscious from the effects of the explosion, but these are reported to have recovered.
