14. Resolved, That a sum not exceeding Twenty thousand dollars be granted to Her Majesty, to provide expenses of buildings for Magazines of Arms and Military Stores at London, Toronto and Kingston; for the financial year ending 30th June, 1867.

15. Resolved, That a sum not exceeding Ten thousand dollars be granted to Her Majesty, to provide Compensation to Pensioners in lieu of land; for the financial year end-

ing 30th June, 1867.

16. Resolved, That a sum not exceeding Seven hundred and thirty-four thousand three hundred dollars be granted to Her Majesty, to defray expenses for General Militia Service; for the financial year ending 30th June, 1867.

Resolutions to be reported.

Mr. Speaker resumed the Chair; and Mr. Street reported, That the Committee had come to several Resolutions.

Ordered, That the Report be received on Thursday next.

Mr. Street also acquainted the House that he was directed to move, That the Com-

mittee may have leave to sit again.

Resolved, That this House will, on Thursday next, again resolve itself into the said Committee.

The House, according to Order, proceeded to take into further consideration the postponed Resolution reported from Committee of Supply, on Thursday, 5th July, instant, and the same was again read, as followeth :-

1. Resolved, That a sum not exceeding Ninety-six thousand five hundred and eighty dollars be granted to Her Majesty, to defray the Salaries and Contingent Expenses of the

Legislative Council; for the financial year ending 30th June, 1867.

And the Question being put, That this House doth concur with the Committee in the said Resolution: It was resolved in the Affirmative.

Mr. Street reported, from the Committee of Supply, several Resolutions, which were read, as follow:-

and its tributaries; for the financial year ending 30th June, 1867.

5. Resolved, That a sum not exceeding Five hundred and ninety-two thousand dollars be granted to Her Majesty, viz.:—To defray expenses towards the completion of the Parliament and Departmental Buildings at Ottawa, the sum of Five hundred thousand dollars; for the residence of His Excellency the Governor General, at Ottawa, the sum of Twentyfive thousand dollars; towards the completion of the Reformatory Prison at St. Vincent de Paul, the sum of Fifty-six thousand dollars; for the Marine Hospital at Quebec, the sum of Six thousand dollars; and for the Prison on Manitoulin Island, the sum of Five thousand dollars; for the financial year ending 30th June, 1867.

6. Resolved, That a sum not exceeding Fifteen thousand dollars be granted to Her Majesty, viz. :- To defray expenses of Arbitrations and awards, the sum of Ten thousand dollars; and for surveys and inspections, the sum of Five thousand dollars; for the finan-

cial year ending 30th June, 1867.

7. Resolved, That a sum not exceeding Ninety-five thousand seven hundred dollars be granted to Her Majesty, to be taken from Special Funds, viz.:-From the Upper
