Copies of the Indictments or Informations prepared against Assistant Judge Des Barres, together with copies of all communications had upon that subject with the Executive and the Law Officers of the Crown, and the Names and additions of the Petty Jurors trying the cause.

Copies of the records of the convictions of the several Prisoners found guilty during the several terms of the Supreme and Central Circuit Courts, during the year 1834, with the sentences passed on each; also, the record of the execution of such several sentences as may have fulfilled the term of their imprisonment.

A copy or copies of the several deprivations of Judge Archibald, and of the commission of Judge Lilly, and the record of his deprivation, together with an enumeration of the cases reserved in the last Sessions of the Northern and Southern Circuit Courts for the opinion of the Judges, as, also, the record of the certification of the records of the late Circuit Courts, and an enumeration of all cases, whether of administration or probate, or of the appointment of Guardians to Idiots and Infants, entertained by the Supreme Court during the year 1834—together with an enumeration of the cases under the Admiralty Law during the same period—(the latter only refers to the sittings in Chambers between terms)

A copy of the swearing into office of the several Sub-Sheriffs during the years 1834 and 35, together with copies of their appointments.

A copy of the transmission through the Governor by the Supreme Court for the approval of the Crown, of such rules and orders as may have been promulgated in that Court during the year 1834, as required by the Charter.

A copy of affidavits sworn to before a Magistrate to justify the swearing in of Special Constables under the 1st and 2nd William 4th cap. 41, together with the names of the Special Constables sworn within the year 1834, and the Magistrate before whom sworn.
