

Docks, Locks and Dams, &c.—Working Expenses—Slides and booms, \$63,933.34; Graving docks, \$19,016.66; Harbour and river works, &c., \$16,275; Collection of Public Works Revenue, \$2,916.67, balance for the year ending 31st March, 1912.

99. Resolved, That a sum not exceeding Two hundred and sixty thousand nine hundred and twenty-five dollars be granted to His Majesty, for Telegraph Lines—Prince Edward Island and the Mainland, \$4,083.33; Land and Cable telegraph lines, Lower St. Lawrence and Maritime Provinces, including working expenses of vessels required for cable service, \$81,666.67; To pay J. C. Taché for services as superintendent at Chicoutimi, \$175; Saskatchewan and Alberta, \$26,250; British Columbia, inclusive of proportion of cost of maintenance of Barkerville-Alberni-Cape Beale Line jointly with Canadian Pacific Railway Company, \$28,000; Yukon system—(Ashcroft-Dawson), \$116,666.66; Telegraph service, generally, \$4,083.34, balance for the year ending 31st March, 1912.

100. Resolved, That a sum not exceeding Four thousand one hundred and ninety-nine dollars and ninety-nine cents be granted to His Majesty, for Post Office—Outside Service—Salaries and Allowances—To provide for the appointment of a Post Office Inspector for the Prince Edward Island Division, \$1,458.33; To provide for the appointment of two additional Assistant Post Office Inspectors, \$1,866.66; To provide for appointing to the permanent staff Messieurs William Finlayson and D. W. Dorion, temporary railway mail clerks, with salaries at the rate of \$750 a year each, \$875, balance for the year ending 31st March, 1912.

101. Resolved, That a sum not exceeding One hundred thousand six hundred and sixty-seven dollars and fifty-eight cents be granted to His Majesty, for Post Office—Outside Service—Mail Service—For mail service in the City of Toronto—Two heavy motor trucks, at \$3,000 each, \$3,500; Four small motor trucks, at \$2,500 each, \$5,833.33; Wages of six chauffeurs and one master mechanic, at an amount not exceeding \$3 a day each, \$3,834.25; For rural mail boxes (revote), \$87,500, balance for the year ending 31st March, 1912.

102. Resolved, That a sum not exceeding Two hundred and thirty-three dollars and thirty-three cents be granted to His Majesty, for Post Office—Outside Service—Miscellaneous—Compassionate allowance of \$200 each to Deome and August Lafleur, for sufferings endured as the result of hardships and privations while conveying the mails of dog teams from Peace River Crossing and Vermillion, in January, 1911, balance for the year ending 31st March, 1912.

103. Resolved, That a sum not exceeding Seven thousand dollars be granted to His Majesty for Trade and Commerce (including inspection of Staples and culling Timber)—Administration of the Chinese Immigration Act, including remuneration to Trade and Commerce and Customs Officers, balance for the year ending 31st March, 1912.

104. Resolved, That a sum not exceeding Three hundred and fifty dollars be granted to His Majesty, for Trade and Commerce—Canada's proportion of expenditure in connection with International Customs Tariffs Bureau, balance for the year ending 31st March, 1912.

105. Resolved, That a sum not exceeding Seventy-two thousand nine hundred and sixteen dollars and sixty-six cents be granted to His Majesty for Trade and Commerce—Trade Commissioners and Commercial Agencies, including expenses in connection with negotiation of treaties or in extension of commercial relations; miscellaneous advertising and printing, or other expenditure connected with the extension of Canadian trade, balance for the year ending 31st March, 1912.

106. Resolved, That a sum not exceeding Four thousand and eighty-three dollars and thirty-four cents be granted to His Majesty, for Trade and Commerce—Bounties on manufactures of steel; lead contained in lead ore; crude petroleum and manilla fibre. To cover expenditure in connection with the administration of the Acts, balance for the year ending 31st March, 1912.
