Mr. ADSHEAD: Section 4 refers to order in council No. 1206 of June 7, 1922, and I would like to ask the sponsor if he would not consent to this bill being amended in order to include the terms of Bill No. 49 recently passed through the house.

Mr. GRAY: As I understand it, Bill No. 49 has not yet become law. I have no objection to the amendment suggested but I am instructed by the Solicitor General (Mr. Cannon), that this bill should pass and the change could be made when Bill No. 49 becomes law.

FOREST FIRES IN NOVA SCOTIA

On the orders of the day:

Mr. W. G. ERNST (Queens-Lunenburg): I should like to direct the attention of the government to the fact that forest fires have been raging through the southern part of Nova Scotia, not only in the county of Yarmouth and Shelburne represented by the Minister of National Defence (Mr. Ralston), but even in worse form in the county of Queens and now, I believe, in the county of Lunenburg. In Queens about 150 people have been rendered homeless and desolate. Relief associations have been formed and the provincial government has made contributions. The city of Halifax and some of the towns and municipalities throughout the province have also made substantial contributions. I should like to ask the government to take under consideration the question of affording substantial relief in connection with this situation. There is a precedent for assistance being given because some years ago it was done in the case of Jamaica.

IMPORTATION OF FRUITS AND VEGETABLES

HEAPS (North Winnipeg): I have a question I should like to put to the Minister of Finance, but as he is not in his seat I shall content myself with asking the question of the Minister of National Revenue. I have had several complaints from Winnipeg with reference to the new duties on fruits and vegetables. According to reports I have received, the increases average from 29 per cent to 386 per cent. EULER (Minister of National Revenue): My attention has also been drawn to an item which appeared, I think, in the Winnipeg Tribune, stating that the department is collecting both specific and ad valorem duties on fruits and vegetables. I would like to say for the information of the house that that is absolutely incorrect. As the house knows, the duties collected are either specific or ad valorem, and that is being carried out now. As regards other statements, we are making investigations, but I think I may assure the house that whatever duty is being collected is being collected under the new schedules.
