hon. gentleman referred to this House. This afternoon, in the name of the Secretary of State for External Affairs, I am receiving a group of Canadian women who will make a representation so I think he will understand that I would like to listen to their representation before making any statement.

Mr. Diefenbaker: Mr. Speaker, the Prime Minister saw fit to make one of his smart aleck remarks—

Some hon, Members: Oh, oh!

Some hon. Members: Shame.

Mr. Diefenbaker: —unused as he is to reading from the record as he speaks. I have before me a document giving the names of these women and I could not memorize them, but because the Prime Minister does not know who they are possibly I should read this.

Mr. Speaker: Order, please. The right hon. member for Prince Albert has put a question which has been referred to the parliamentary secretary. If he has a supplementary question perhaps he would put it right away.

Mr. Diefenbaker: Mr. Speaker, a gratuitous and insulting remark was made. However, he is improving; he does not use four-letter words any more. Mr. Speaker, on a question of order I raise this point—

Mr. Speaker: Order, please.

Mr. Diefenbaker: I have been here long enough to know the rules.

Mr. Speaker: Order, please. If the right hon, member or any other member has a point of order it can be taken at three o'clock. The hon, member for Winnipeg North Centre.

EFFECT ON GUARANTEED INCOME SUPPLEMENT OF RECEIPT OF FAMILY ALLOWANCE BY GRANDPARENT RAISING GRANDCHILD

Mr. Stanley Knowles (Winnipeg North Centre): Mr. Speaker, may I direct a question to the Minister of National Health and Welfare. In view of the fact that grandparents receiving old age security and the guaranteed income supplement who are called upon to raise their grandchildren find that the family allowance paid for the grandchildren to the grandmother results in the guaranteed income supplement paid to the grandparents being reduced, even though this may happpen in just a few cases, will the minister look at it in the hope that this unfairness can be corrected.

Hon. Marc Lalonde (Minister of National Health and Welfare): Mr. Speaker, I thank the hon. member for having drawn this matter to my attention before. I am sure this is a matter which probably escaped the attention of all members of parliament when we were considering family allowances and the OAS legislation. I am looking into it

further and assessing the actual situation. I hope that after review, if what the hon. member says is the exact situation, we shall be able to remedy this situation at the first opportunity.
