REVENUE FROM CORPORATE INCOME TAX

Ouestion No. 442-Mr. Howie:

In the fiscal year ending March 31, 1983 what was the total revenue collected from corporate income tax?

Hon. Pierre Bussières (Minister of National Revenue): \$7,139 million.

PAYMENTS FOR REMOVAL OF UFFI

Ouestion No. 461-Mr. Howie:

In the period April 1, 1983 to date, did the government make any payments for removal of urea formaldehyde foam insulation from homes and buildings in Canada and, if so, what was the total (a) amount (b) number of individuals or groups in receipt of them?

Hon. Judy Erola (Minister of Consumer and Corporate Affairs): Yes, the Government did make payments to owners of homes insulated with urea formaldehyde foam insulation, not only for the purpose of removing the insulation but also for other measures, such as sealing and ventilation, to correct problems associated with the insulation.

In (a) the current fiscal year (b) each of the two preceding fiscal years, with respect to the Natural Sciences and Engineering Research Council (i) what total amount was expended by the Council (ii) how many persons were employed by the Council (iii) what amount was expended for staff remuneration?

Mr. Rolland Dion (Parliamentary Secretary to Minister of State for Economic and Regional Development and Minister of State for Science and Technology): In so far as the Natural Sciences and Engineering Research Council is concerned, the answers are as follows:

 - (a) 1983-84: 261,120,000
 - (b) 1982-83: 244,438,439

1981-82: 201,141,009

- (ii) Number of persons (person-years) employed by the Council:
 - (a) 1983-84: 111 person-years allocated
 - (b) 1982-83: 98 person-years allocated; 95.5 person-years used

1981-82: 81 person-years allocated; 76.5 person-years used

- (iii) Amount expended for staff remuneration:
 - (a) 1983-84: 3,194,000
