## MR. SKELLY—ELECTORAL BOUNDARIES

**Mr. Ray Skelly (Comox-Powell River):** Madam Speaker, I have the honour to present to the House of Commons a petition from several hundred residents of the Sechelt Peninsula requesting that the House, during consideration of objections to the Electoral Boundaries Readjustment Act, consider their request to remain within the North Island-Powell River electoral district on the grounds that they were not able to make presentations to the Electoral Boundaries Commission when it sat in British Columbia. Hearings were held long distances from the Sechelt area and it would be the residents' request that they be allowed to remain with electors who have a community of interest.

## MR. TAYLOR—CLIFFORD ROBERT OLSON

**Mr. Gordon Taylor (Bow River):** Madam Speaker, I am pleased to accede to the wishes of 2,000 more Canadians who herewith petition the Government and the Hon.
