evidence to shore up his argument here? He may do that. Hon. Members know that very well.

Mr. Lanthier: Mr. Speaker, you are right if you assume that the only source of my remarks, irrelevant though they may appear, are arguments which have already been made.

Last night the Caisses populaires—represented not by one individual or only by the president but by the entire board of directors—stated formally that they supported the Minister. We did not have any choice, it was our moral and contractual responsibility to do what we are doing now, it was quite clear. The people were disappointed when they asked that question. Their answer was unequivocal and there was no arm twisting, Mr. Speaker.

Those people support the Government. The National Bank which had been accused of being a regional institution but has branches in five Canadian provinces where it is strongly represented said the same thing last night: those people fully support the Government in this operation, not only the rescue operation but the other operation whereby all depositors will get their money back.

So if I may, Mr. Speaker, I think those things need to be said if we want to set the record straight. If anything at all has been twisted, it was not the arms of bankers but rather the truth as the tired Liberal Opposition sees it.

Mr. Speaker, I think reference was then made to decisions taken without full knowledge of the facts. Earlier someone said something about remarks allegedly made by some bankers who apparently offered the services of their staff to make an audit. What they omit to say, Mr. Speaker, is that the offer was accepted. The books were audited by the Inspector General of Banks with the help of experts sent by the banks.

Of course, we were under pressure. But the banks... the Canadian Bankers' Association said that it had been involved in the study. The Bankers' Association was invited. All the big bankers, that weekend, were not on holiday but on duty. And the bail-out of the Canadian Commercial Bank was endorsed by all and they all had the choice to open or not to open the bank on Monday morning. Everybody decided to open the bank. It was a common decision, a joint venture, a partnership. This decision was not imposed by the Government.

Therefore, Mr. Speaker, the decision regarding both banks that some tried to lump together in the debate tonight, in particular the Northland Bank, was I believe a difficult one to take. I am proud that it was taken by such a responsible and able person as our Minister of State for Finance (Mrs. McDougall). Her integrity is unquestionable and her decisions have been endorsed by all the leading experts on banking institutions in Canada. I wish I had been there when they took the reverse position and when the Opposition Leader was called to order by our valiant Prime Minister (Mr. Mulroney) when they said to him: Bring out the real facts or, if you are unable

to prove them, say it outside the House, and then we will be armed to ask you questions.

As I said before, Mr. Speaker, this institution was endorsed by the leading banking institutions. We have taken our contractual and moral responsibilities towards all Canadian citizens and the decision was not only made by an honest and able person but also with full knowledge of the facts . . . I am happy not to have been cornered into taking that decision and I am proud as a Canadian that it was taken by such an able person.

Mr. Jean-Robert Gauthier (Ottawa-Vanier): Mr. Speaker, I would like to ask the House whether we could let our pages go, as well as some of those who work for members of Parliament in the lobbies, before we go on with the debate. I wish to thank them and if there is unanimous consent, we might let the pages go home.
