

Copies of each of which Orders in Council were laid before this House on the 1st of December, 1911, for the approval of this House, under the provisions of Section 19 of the Dominion Forest Reserves and Parks Act, are now so approved.

4. Resolved, That the following Orders in Council made by His Excellency the Governor General in Council under the provisions of the Yukon Act, 2 E. VII, Chapter 34, on the dates respectively mentioned, that is to say:—

(1) P. C. No. 1036, dated 16th May, 1911, suspending for ten years, the payment of royalty or export tax upon gold extracted or obtained from quartz in the Yukon Territory.

(2) P. C. No. 2170, dated 31st May, 1911, amending the Dredging Regulations for the Yukon Territory, approved by Order in Council of the 14th May, 1907.

Bill No. 190, An Act to authorize a bounty to Volunteers who served the Crown during the Fenian Raids.
