

Mr. Howe, a Member of the King's Privy Council, then laid before the House,—Copy of an Agreement between Canada and Australia for Air Services between the two countries, signed in Ottawa, July 11, 1946 (Treaty Series 1946, No. 22).

The House resolved itself again into Committee of Supply, and further progress having been made and reported, the Committee obtained leave to sit again, later this day.

By leave of the House, on motion of Mr. St. Laurent, it was resolved,—That notwithstanding the terms of Standing Order 6, when Mr. Speaker leaves the Chair at six o'clock, p.m., this day, the intermission extend only to seven o'clock, p.m., instead of eight o'clock, p.m.

A Message was received from the Senate informing this House that the Senate had passed the Bill No. 251, An Act to establish The Canadian Commercial Corporation, with amendments, which are as follows:—

1. *Page 2, line 31.* After "Canada", insert the word "and".
2. *Page 2, line 32.* Delete the word "and".
3. *Page 2, line 33.* Delete the following "(c) storing and processing goods or commodities,".
4. *Page 3, line 36.* Delete the words "a statement of such accounts" and substitute therefor the words "his report".
5. *Page 4, lines 18 and 19.* Delete the words "in such form as the Minister may prescribe".
6. *Page 4, line 20.* After the word "March" insert the following words: "containing its financial statements and such information as is required to be furnished to shareholders by a company incorporated under *The Companies Act, 1934*, and such other information as the Minister may prescribe".
7. *Page 5, after line 39.* Insert the following as clause 17:—
  17. (1) This Act shall expire sixty days after the commencement of the first session of Parliament commencing in the year one thousand nine hundred and forty-nine.
  - (2) Section nineteen of the *Interpretation Act* shall apply upon the expiry of this Act as if this Act had then been repealed.

The amendments made by the Senate to the following Bills were taken into consideration and severally concurred in, viz:

Bill No. 370, An Act to amend The Excess Profits Tax Act, 1940.

Bill No. 372, An Act to amend the Special War Revenue Act.

Bill No. 392, An Act to amend the Militia Pension Act.

The Order being read for concurrence in amendments made by the Senate to Bill No. 195, An Act respecting the Control of the Acquisition and Disposition of Foreign Currency and the Control of Transactions involving Foreign Currency or Non-Residents;

Mr. St. Laurent moved,—That the said amendments be read the second time and concurred in.

After Debate thereon, the question being put on the said motion; it was agreed to.

The said amendments were accordingly read the second time and concurred in.

At six o'clock, p.m., Mr. Speaker left the Chair, to resume the same at seven o'clock, p.m., pursuant to Special Order made this day.
