WANNAMAKER SENT FOR RIAL CHARGED WITH HAVING "STILL" Judgment Reserved On Lesser Liquor Charge.

Paraphernalia Found

But Defence Says It Was Not Used for Illegal Purpose.

On the charge of having a private still at his residence, 668 St. James street, John A. Wannamaker appeared before Magistrate A. H. M. Graydon in police court this morning, and was committed for trial. On another charge, that of having liquor in other than a private dwelling, he was tried, but judgment was reserved until Thursday.

P. C. William T. Middough, in company with P. C. Philip W. Harper, had gone to Wannamaker's on Saturday night to search for liquor. He reported that there was a fierce fight in progress there. On investigating, a large quantity of liquor was discovered. It contained 52.29 per cent proof spirits, was found on the floor of a shed some 100 feet from the house. The policeman salvaged a great deal of it. It contained 3.91 per cent proof spirits. J. M. McKee, counsel for the accused, premises, but the constables claimed that it was inside.

Next the policeman searched the barn and the vicinity. Near the northwest corner of the barn a two-gallon cask of 52.29 per cent liquor was discovered. Mr. McKee was of the opinion that this was found outside the limit of the accused's premises, but the constables claimed that it was inside.
