Mr. Ed. Lumley (Parliamentary Secretary to Minister of Regional Economic Expansion): The reply for the Department of Regional Economic Expansion is as follows: 1. DISPOSAL OF CANADIAN STAMP IN CANADA

Ouestion No. 2.909-Mr. Gillies:

- 1. Did the Post Office Department or any other agency under the direction of the Department, within the past eighteen months dispose of a quantity of Canadian stamps in Canada at less than face value and, if so (a) what issues were involved (b) at what price, relative to face value, were they sold (c) what was the total price?
 - 2. Were the stamps sold by public tender and, if so, how were bids obtained?
- Hon. J.-J. Blais (Postmaster General): 1. Yes; (a) 12 Olympic Stamps were involved. (b) The stamps were sold in bulk for \$3.15 which was \$1.85 below their face value. They formed part of an Olympic Souvenir Stamp Case and were affixed to a panel embedded in the lid of the case. The Olympic Souvenir Stamp Case was sold to generate revenue in financial support of the 1976 Summer Olympics. Toward the end of 1976 when it was realized there would be a surplus inventory of the case, bulk sales at a special price were authorized to sell-off this inventory and to thereby maximize net revenues to be credited to the Olympics. (c) \$155,600.

SOLAR ENERGY SOCIETY OF CANADA

Question No. 2,910—Mr. Gauthier (Roberval):

- 1. Is the Solar Energy Society of Canada incorporated and, if so, what are the names of the directors?
- 2. (a) What are the Society's source of funds (b) has the government made grants to the Society and, if so, in what amount each year since its incorporation?
 - 3. To date, what are the Society's achievements?

Mr. Ralph E. Goodale (Parliamentary Secretary to President of the Privy Council): I am informed by the National Research Council and the Department of Energy, Mines and Resources as follows: 1. The Solar Energy Society of Canada was incorporated in Winnipeg, Manitoba on the October 18, 1974, as a non-profit corporation under part 3 of the Manitoba Companies Act. The society is managed by a 12 member board of directors which are nominated and elected. Detailed business is performed by a "Winnipeg Executive" which is comprised of members of the board: the Chairman and/or Vice-Chairman, the Secretary, the Treasurer (Vice-Chairman Finance) and the Chairman of the Editorial Board. The minutes of the meetings of the Winnipeg Executive are circulated to all members of the board and decisions on important items are made by letter ballot or approved at full board meetings. There are 15 Chapters and 6 regions; British Columbia, Prairie, Ontario, Quebec, New Brunswick and Newfoundland.
