

Lotbinière.

The Circle (*arrondissement*) of Lotbinière shall comprehend all that part of Buckinghamshire lying within the District of Quebec, and which may not make part of the Inferior District of St. Francis, and the Circuit Court for the same, shall be held at the Parish of Lotbinière.

Cape Santé.

The Circle (*arrondissement*) of Cape Santé shall comprehend all that part of the county of Hampshire lying within the District of Quebec, with the exception of the Parishes of St. Augustin and Ancienne Lorette, annexed to the Circle (*arrondissement*) of Quebec, and the Circuit Court for the same shall be held at the Parish of Cape Santé.

Division of the District  
of Montreal into Circles.

XLVIII. And be it further enacted by the authority aforesaid, that the District of Montreal shall be, and the same is hereby divided into Circles, (*Arrondissements*), as follows, that is to say: The Circle (*Arrondissement*) of Montreal, shall comprehend the Island of Montreal and its dependant Islands, the County of Kent, the Parish of Varennes, the Seigniorship of La Prairie de la Magdeleine, the Seigniorship of Sault St. Lewis; and, that the Court for the said Circle (*Arrondissement*) shall be held in the place heretofore fixed for holding the Court of King's Bench for the District of Montreal.

Vaudreuil.

The Circle (*Arrondissement*) of Vaudreuil, shall comprehend all that space between the River St. Lawrence and the River Ottawa, the Isle Perrault, the Seigniorship Beauharnois and its dependant Islands, the Townships of Godmanchester, Hinchinbrooke, and the Lands appertaining to the Indians at St. Regis; and the Circuit Court for the same shall be held at the Parish of Soulanges.

Ottawa.

The Circle (*Arrondissement*) of Ottawa, shall comprehend all that part of the County of York situate above the Seigniorship of *La Petite Nation*; and the Circuit Court for the same shall be held at the Township of Hull.

St Eustache.

The Circle (*Arrondissement*) of Saint Eustache, shall comprehend all that part of the County of York which is not included in the Circle (*Arrondissement*) of Vaudreuil, as well as all that part of the County of Effingham which is not hereby included in the Circle (*Arrondissement*) of Montreal; and the Circuit Court for the same shall be held at the Parish of Saint Eustache.

L'Assomption.

The Circle (*Arrondissement*) of *L'Assomption*, shall comprehend the Counties of Leinster and Warwick; and the Circuit Court for the same shall be held at the Parish of *L'Assomption*.

Richelieu.

The Circle (*Arrondissement*) of Richelieu, shall comprehend all such part of the County
