

Mr. Justice *Saunders* delivered the Message.

Mr. *Speaker*,

"The Council have agreed to the Gypsum Bill;" and then Mr. *Saunders* withdrew.

Ordered that Mr. *Street* and Mr. *Johnston*, do carry up to the Council, the Resolves of yesterday; and desire their concurrence.

The *Speaker* left the Chair. Mr. *Humbert* resumed the Chair of the Committee. Mr. *Speaker* resumed the Chair.

Mr. *Humbert* from the Committee, reported that he was directed by the Committee to report that they had agreed to the Bill before them under its title with an amendment, and he delivered the Bill at the Clerk's Table, which being read as amended, was ordered to be engrossed.

Ordered that Mr. *Street* and Mr. *W. Pagan*, be a Committee to prepare and bring in a Bill to continue and amend an Act, entitled "An Act to provide for the more effectually repairing the Streets and Bridges in the City and County of St. John, which was brought in and read a first time."

The House then adjourned until Monday morning next at 11 o'Clock.

A Bill to exclude ignorant and unskilful Persons from the practice of Physic and Surgery.

A Bill to establish Grammar Schools in several Counties of this Province.

A Bill more effectually to provide for the support of a nightly Watch in the City of Saint John.
