EXCELLENCY,

I have the honour to refer to recent discussions between representatives
of the Ministry and of the Canadian Embassy concerning the Convention on
Legal Proceedings in Civil and Commercial Matters concluded between the
United Kingdom and Germany on March 20, 1928. The accession of Canada
to this Convention in accordance with the provisions of Article 12a was effected
by Her Majesty's Charge d'Affaires on July 14, 1953. The accession
came into effect on August 1, 1953.
